Seeing your doctor once a year for a well visit helps you get and stay healthy. During this checkup, you and your doctor will talk about your overall health and your health goals.

You'll also complete a *Health Risk Assessment* form. An HRA is a tool that gives you and your doctor a place to start making the health care choices that are right for you.

We're excited to offer you a reward for taking a few steps to stay healthy. Your reward may be a \$50 gift card or a 50 to 100 percent discount on your cost-sharing contribution, depending on your income.

This reward is our way of saying thank you for completing a *Health Risk Assessment* form with your doctor and committing to making healthy choices.

## It's easy to claim your reward.

- 1. Call your doctor to schedule your well visit.
- 2. Fill out sections 1 through 3, and your name and address on the enclosed *Health Risk Assessment* form. The form is also on our website, **mibluecrosscomplete.com**.
- 3. Take your *Health Risk Assessment* form with you to your doctor's appointment. Your doctor will complete section 4 and return it to Blue Cross Complete of Michigan.

This doctor's visit is part of your covered health benefits. We can also help you get a ride to your appointment. You can call 1-888-803-4947 (TTY: 711) to schedule your ride.

Completing your *Health Risk Assessment* each year is a way you can show your commitment to healthy behaviors. For members with income at or above 100 percent of the federal poverty level, this may be required to retain enrollment in your Medicaid health plan.

Dental health is an important part of healthy living. So, don't forget to include your dentist in your yearly schedule of healthy appointments. The information you provide in this form is personal health information protected by federal and state law and will be kept confidential. It CANNOT be used to deny health care coverage.

We also encourage you to see your doctor for a check-up as soon as possible after you enroll with a health plan, and at least once a year after that. An annual check-up appointment is a covered benefit of the Healthy Michigan Plan. Contact your health plan if you need transportation assistance to get to and from this appointment.

- Answer the questions in sections 1-3 as best you can. You are not required to answer all of the questions.
- Call your doctor's office to schedule an annual check-up appointment. Take this form with you to your appointment.
- Your doctor or other primary care provider will complete section 4. He or she will send your results to your health plan.
- There is a Healthy Behavior Reward for agreeing to address or maintain healthy behaviors on your health risk
  assessment. This reward can be a gift card or a reduction in monthly MI Health Account payments, depending
  on your income.
- Don't forget to complete a new health risk assessment each year.

After your appointment, keep a copy or printout of this form that has your doctor's signature on it. This is your record that you completed your annual Health Risk Assessment.
